Hong Kong legalizes crypto trading sparking outcry from Brian Armstrong

Hong Kong citizens will reportedly be allowed to buy, sell, and trade crypto assets from June 1, according to the Twitter account @NoodleofBinance. The report comes as a narrative is brewing that China is warming to cryptocurrency and seeks to implement pro-crypto regulation in Hong Kong as a sort of sandbox evaluation. The June 1 deadline is expected to apply to accredited investors while excluding retail, but many are optimistic that retail investors will have increased crypto access in time. Coinbase CEO Brian Armstrong pointed to the report as a potential catalyst for the U.S. losing its status as the world's financial hub, given the U.S.'s comparatively poor clarity on crypto regulation.

Paxos to Stop Minting Stablecoin BUSD Following Regulatory Action

Stablecoin issuer Paxos will stop minting new Binance USD (BUSD) stablecoins at the direction of the New York Department of Financial Services (NYDFS), with the news coming just after a report that the U.S. SEC threatened legal action. NYDFS said that it had instructed Paxos to cease minting BUSD due to several unresolved issues related to Paxos' oversight of its relationship with Binance. Paxos resultantly said it is ending its relationship with Binance for BUSD. The SEC's notice also informed Paxos that it's considering an enforcement action against them for failing to register BUSD as a security. Paxos disagreed with the SEC's allegations, noting it's

prepared to "vigorously litigate" the disagreement if forced to do so. Bloomberg reported that Circle, the issuer of the competing stablecoin USDC, was the whistleblower that tipped off the NYDFS to investigate Paxos.

Binance Bracing Itself for Fines From US Regulators to Settle ‘Past Conduct’: WSJ

As U.S. regulators continue to sniff around Binance, the world’s largest crypto exchange is prepared to pay monetary penalties to “make amends” for past regulatory violations. Binance Chief Strategy Officer Patrick Hillmann told the WSJ on Wednesday that the exchange grew quickly and was not initially aware of the myriad laws and regulations designed to prevent money laundering, sanctions evasion, and corruption. Because of that, Hillman said Binance expects to face fines – and is “working with regulators to figure out what are the remediations we have to go through now to make amends for [past violations]. Hillman declined to estimate the size of the fines or a timeline for when the investigation might be settled as he noted discussions are still ongoing, but he did add that he was “highly confident and feeling really good about where those discussions are going."

SEC proposes tougher rules as part of its crypto custody crackdown

A five-member panel of the U.S. SEC has voted 4-1 in favor of a proposal that may make it more difficult for cryptocurrency firms to serve as digital asset custodians in the future. The proposal, which is yet to be officially approved by the SEC, recommends amendments to the “2009 Custody Rule” will apply to custodians of “all assets” including cryptocurrencies, according to a Feb. 15 statement from SEC Chairman Gary Gensler. In order to become a “qualified custodian” under the newly proposed rules, U.S. and offshore firms would additionally need to ensure that all custodied assets — including cryptocurrencies — are properly segregated, while these custodians will be required to jump through additional hoops such as annual audits from public accountants, among other transparency measures.

SEC charges Terraform and Do Kwon post Terra collapse

The U.S. SEC charged Terraform Labs and its CEO Do Kwon over its algorithmic stablecoin Terra USD, which collapsed dramatically last year. The agency said the



Singapore-based company and Kwon raised billions from investors by “offering and selling an inter-connected suite of crypto asset securities, many in unregistered transactions.” “We allege that Terraform and Do Kwon failed to provide the public with full, fair, and truthful disclosure as required for a host of crypto asset securities, most notably for LUNA and Terra USD,” said SEC Chair Gary Gensler in a statement announcing the enforcement action. “We also allege that they committed fraud by repeating false and misleading statements to build trust before causing devastating losses for investors.”

Polygon sets late March launch date for its zkEVM mainnet beta

The Ethereum scaling solutions provider Polygon is preparing to launch its long-awaited zero-knowledge Ethereum Virtual Machine rollup (zkEVM). In a Feb 14 blog post, Polygon said that after three and a half months of “battle testing,” the system will be ready for its beta mainnet launch next month on Mar 27.

General-purpose zero-knowledge rollup technologies are widely viewed as the end-game for Ethereum scaling solutions, and the race to ship the first zkEVM has been highly competitive and heating up in recent months. One competitor, zkSync, followed Polygon's announcement revealing that pre-registered developers can now deploy apps on its zkEVM before a mainnet launch in the month's ahead.
