### **China Quietly Supporting Hong Kong's Proposal to Allow Retail Bitcoin and Crypto Trading: Report**

China appears to be quietly on board with Hong Kong's potential move to allow retail trading of Bitcoin and crypto assets, according to a new report. Hong Kong's Securities and Futures Commission (SFC) released a consultation paper this week, outlining a plan to provide regulated crypto trading licenses to companies and allow investors both large and small to buy cryptocurrency. As Hong Kong moves toward relaxing its policies on crypto, Chinese officials – including representatives from China's Liaison Office – have been regularly spotted at Hong Kong's crypto gatherings in recent months, according to Bloomberg. The encounters have been friendly, with officials checking on developments, asking for reports and in some cases making follow-up calls." The SFC is proposing a regulatory process that would require all crypto assets be fully vetted and pre-approved before they can be listed on exchanges. The agency has already decided to allow investors with \$1 million or more to buy crypto assets, beginning on June 1st.

### **Crypto Exchange Coinbase Launches Ethereum L2 Scaling Network Called Base**

Coinbase is joining the competition of Ethereum L2 scaling projects, such as Arbitrum, Optimism, Starknet, and others, by launching an L2 called Base. The company announced the launch of the Base testnet on Thursday and advised the public to stay tuned for the upcoming mainnet launch. The cryptocurrency exchange

explained that Base will be open-source and will leverage Optimism's OP Stack. Coinbase also detailed that it's collaborating with Optimism and it'll join them as a core dev on the OP stack. "We see this toolkit as an open platform that anyone can contribute to, fork, and extend to help the crypto economy scale," Coinbase's blog post said. The announcement also stressed that there are "no plans to issue a new network token" and Base will be powered by ETH. Lastly, Coinbase announced the launch of a Base Ecosystem Fund to support early-stage projects working with Base.

### **SBF facing multiple fraud, conspiracy charges in unsealed superseded indictment**

FTX founder Sam Bankman-Fried (SBF) is facing additional charges in the latest superseding indictment unsealed on Feb. 23. The indictment — unsealed in the U.S. District Court in Manhattan, where SBF was originally charged — includes a total of 12 charges, four of which are new. It also reveals new details of the illegal political donations SBF made to curry favor in Washington. The new indictment charged SBF with securities fraud; wire fraud; multiple counts of conspiracy related to committing wire fraud on Alameda's lenders and FTX customers; money laundering; operating an unlicensed money transmitting business; bank fraud; and illegal campaign contributions. SBF has so far plead not guilty to all charges in his case. Elsewhere in FTX news, the defunct exchange's former director of engineering, Nishad Singh, is expected to be the latest member of SBF's inner-circle to plead guilty to fraud charges as he's reportedly negotiating a plea deal similar to Caroline Ellison and Gary Wang before him.

### **Blur Blows Away OpenSea and Wins 82% of NFT Trading Volume**

It's a time-honored tenet of business — slash prices and the customers will come. Tell that to OpenSea. One week after the NFT marketplace scrapped the fee it collects on trades, Blur, its upstart rival, hasn't missed a beat. The four-month-old NFT marketplace has seized a staggering 82% marketshare of the trading volume on Ethereum over the last week. Blur cranked into overdrive after the project airdropped 12% of its BLUR tokens to NFT traders on Feb. 14. It has accounted for more than 70% of daily NFT trading volume on Ethereum for every day since the airdrop, prompting OpenSea to cut fees. OpenSea also dropped enforced royalties to 0.5% on this same day, marking a big deviation from its past strategy.



## **Judge denies Dapper Labs request to dismiss NBA Top Shot security lawsuit**

A U.S. district court judge on Wednesday denied Dapper Labs' request to dismiss a lawsuit alleging that the NBA Top Shots NFT collection is an unregistered security. District Judge Victor Marrero wrote that the Dapper Labs' NFT collection appears to meet the requirements of a security under the Howie Test. The ruling on the motion comes ~18 months after a class action lawsuit was filed against Dapper Labs and its CEO for failing to register the sale of Top Shots NFTs as securities with the SEC. Importantly though, the ruling was narrow and pointed to many case-specific points of entanglement between the success of Dapper Labs and the FLOW blockchain to the success of the NBA Top Shots NFTs, noting that other NFTs may or may not be securities and need to be evaluated on a case-by-case basis.
