CFTC sues Binance and its CEO 'CZ' for allegedly violating US laws

Binance and its CEO Changpeng "CZ" Zhao are being sued by the Commodity Futures Trading Commission (CFTC) for allegedly violating federal laws and not registering the exchange in the U.S. Since 2017, Binance has "taken a calculated, phased approach to increase its United States presence despite publicly stating its purported intent to 'block' or 'restrict' customers located in the United States from accessing its platform," the agency argued in the 74-page complaint. The complaint adds that Binance, Zhao and former CCO Samuel Lim "have all chosen to ignore those requirements and undermined Binance's ineffective compliance program by taking steps to help customers evade Binance's access controls," the agency said. A Binance spokesperson said, "The complaint filed by the CFTC is unexpected and disappointing as we have been working collaboratively with the CFTC for more than two years."

Signature Bank's Crypto Depositors Get April 5 Account Closure Deadline

The Federal Deposit Insurance Corporation (FDIC) has asked cryptocurrency clients of collapsed Signature Bank to close their accounts by April 5 by finding another banking partner. Otherwise, the regulator will close the accounts and mail a check to the registered addresses. The FDIC's decision on Tuesday came following the acquisition of Signature Bank's deposits and loans by Flagstar Bank, a part of the New

York Community Bancorp (NYCB). However, the acquisition did not include the "approximately \$4b of deposits related to the former Signature Bank's digital banking business." In related news, the Chair of FDIC confirmed earlier this week that the agency is still seeking to find a buyer for Signature's Signet.

'Withdrawals are coming!' — Ethereum devs confirm epoch for Shapella fork

Ethereum validators will soon be able to withdraw their staked ETH from the Beacon Chain, with the Shapella hard fork set to be activated on the Ethereum mainnet on April 12 (epoch 194,048; 5:27 pm EST). The withdrawals will be enabled by EIP-4895 by "pushing" staked ETH from the Beacon Chain to the execution layer. The upgrade will allow staked ETH to be withdrawn for the first time since the Beacon Chain's launch in 2020, but withdrawals may take weeks or even months to execute after the upgrade is implemented depending on the number of validators that attempt to exit. GSR's monthly crypto commentary will provide a detailed dive into these withdrawal dynamics early next week.

Polygon's Zero-Knowledge Rollup Goes Live On Mainnet

Polygon has released its zero-knowledge layer 2 rollup, becoming the second company in four days to make a so-called 'zkEVM' available to the general public. The release follows zkSync Era's mainnet launch last week. Zero-knowledge rollups are considered the most promising technology to scale Ethereum, and the launch of general purpose zkEVMS represent a pivotal industry development. Polygon's zkEVM remains in beta, and the company stressed that it should be used with caution today.

First Citizens Bank Enters Deal With FDIC to Buy Silicon Valley Bank

First Citizens Bank will take on the deposits and loans of the failed Silicon Valley Bank, the U.S. Federal Deposit Insurance Corporation (FDIC) said on Monday. The deal includes the purchase of \$72b in SVB assets for a discount of \$16.5b. The FDIC will keep another \$90b in securities and assets to sell on the open market in a process known as "disposition." First Citizens, a 125-year-old institution with a focus on North Carolina and South Carolina, had around \$100 billion in total assets prior to the deal. Importantly, the First Citizens chairman and CEO said the acquisition would mean that the bank would continue to serve various startup-centric and VC clients.
