Top crypto exchange Binance fined \$4.3b as CEO pleads guilty to U.S. money laundering violations

The Basis Point

The world's largest cryptocurrency exchange Binance reached a settlement with the US Department of Justice and admitted to anti-money laundering, unlicensed money transmitting, and sanctions violations. Binance also reached agreements with the CFTC, FinCEN, and OFAC. Under the terms of the agreement, Binance will pay \$4.3b in penalties and forfeiture, completely exit the US, and retain an independent compliance monitor for three years. Further, CZ, who also pled guilty to violating the Bank Secrecy Act and will be sentenced in February, stepped down from his role as CEO and is prohibited from having any involvement in Binance for three years. Richard Teng, Binance's regional markets head and former Abu Dhabi regulator, will now lead the exchange.

Mt. Gox Creditors to Receive Bitcoin Payments Starting 2023 Based on Rehabilitation Plan

A decade after the Mt. Gox crypto hack, creditors have been informed of a repayment plan beginning in 2023. In an email sent to rehabilitation creditors on Wednesday, the trustee overseeing the Mt. Gox bankruptcy estate announced plans to commence repayments in 2023, with the process extending into 2024. The rehabilitation plan involves repaying creditors approximately 141,686 BTC (\$5.2b at current prices) and 143,000 Bitcoin Cash (BCH) (\$31m) from the Mt. Gox estate and will start with cash repayments.

Layer-2 network Blast becomes third-largest holder of staked Ethereum amid pyramid scheme allegations

Blast, a newly introduced Ethereum layer-2 network promising “native yield” on ETH and stablecoins, has already amassed over \$380m in staked ether, making it the third-largest holder just three days post-launch. However, the rapid growth of Blast has triggered strong criticism within the crypto community due to its pyramid-like Blast points system, which rewards early users based on the number of users they refer.

Grayscale Investments recently met with the Securities and Exchange Commission as it continues to seek approval for its application to convert its Grayscale Bitcoin Trust into a spot bitcoin exchange-traded fund. The asset manager met with officials from the SEC's division of trading and markets on Monday to discuss potential listing matters concerning the shares of the product.

SEC sues Kraken over unregistered exchange operations, commingling of funds

The SEC filed charges against the cryptocurrency exchange Kraken, accusing it of operating an unregistered securities exchange, broker, dealer, and clearing agency. Furthermore, the SEC said that Kraken commingled customer and corporate funds, including by paying operational costs from accounts that held user funds. Kraken denied the allegations and vowed to fight the lawsuit.

Argentina elects pro-Bitcoin president Javier Milei

A runoff election in Argentina on Sunday resulted in a win for Javier Milei, a libertarian on the political right who wants to dollarize the country’s economy and has expressed support for Bitcoin.
