### Rising Bitcoin Fees Prompt Renewed Battle Over Ordinals, BRC-20 Tokens

Alongside the euphoria among investors over Bitcoin's recent surge above \$44,000, increased network congestion is prompting another battle over the NFT-like Ordinals project and BRC-20 tokens. More than 46m such inscriptions have been made since January, including inscriptions tied to BRC-20, a type of fungible token minted on the Bitcoin blockchain. Opponents call Ordinals a misuse of the Bitcoin network and cite their impact on everyday users in the form of higher transaction fees, while proponents argue that Bitcoin is a free and open protocol and that higher transaction fees is what will replace Bitcoin's declining security budget.

### SEC, Spot Bitcoin ETF Issuer Talks have “Advanced to Key Details”

News

Discussions between the SEC and spot Bitcoin ETF issuers have progressed to "key details," signaling the possibility that the SEC will approve the applications. Specifically, the SEC and the issuers are reportedly discussing key operational mechanics, such as in-kind versus cash creations. Assuming the SEC wants to approve all applications at once, industry analysts have pegged the approval window to be between January 5th and January 10th, 2024.

### El Salvador's Bitcoin Investment 'In the Black,' Says President Bukele

El Salvador's president took to X to announce that the country's bitcoin investment is now profitable. He also added that they have no intention of selling and that price volatility doesn't affect their long-term strategy. El Salvador owns roughly 2,744 bitcoin at an average price slightly below \$42,000.

## **Crypto-fueled wireless carrier Helium Mobile debuts unlimited nationwide plan in US**

Helium Mobile launched a nationwide cellular phone plan in the US for unlimited data, text and talk that costs just \$20 a month. The service combines the peer-to-peer Helium Network, an internet-of-things project that uses the Solana blockchain, and a nationwide 5G network.

## **Brazil's largest bank Itau Unibanco launches Bitcoin trading**

Brazilian bank Itaú Unibanco launched a cryptocurrency trading service for its clients, starting with Bitcoin and Ether (and with plans to add more cryptocurrencies in the future). Itaú will serve as the custodian for the service, storing crypto assets for its clients. Initially, clients will not be able to deposit and withdraw cryptocurrency using external wallets, but will have the guarantee of Itaú's balance sheet for security.

## **Bitcoin miner Riot Platforms gears up for halving with strategic \$290M hardware investment**

Texas-based Bitcoin miner Riot Platforms has acquired 66,560 units of BTC miners from MicroBT for \$290.5m, representing 18 EH/s of hash rate. Riot also has options to acquire an additional 265,000 miners, aiming to achieve a 100 EH/s hash rate capacity.
