Spot Bitcoin ETF approval still happening by Jan. 10, analysts say

Analysts expect the US SEC to approve a spot Bitcoin ETF in January 2024, despite last-minute amendments by applicants. BlackRock's latest update accepted the SEC's cash redemption system, but included a change around a "prime execution agent" that may not be accepted. Despite the frequent back and forth and different applicants still proposing different constructions, most see the ongoing meetings between the SEC and ETF filers as a positive sign for January.

China Vows to Clarify Web3, NFT Development Path

China's Ministry of Science and Technology announced plans to release a Web3 strategy document to clarify the path forward for the industry. The strategy document would handle the issues of inheritance, innovation, security and government obligations. In addition, the ministry plans to strengthen interaction between relevant departments to promote Web3 innovation, deploy further research, and strengthen talent in the industry.

Why a gold rush for inscriptions has broken half a dozen blockchains

Like Bitcoin Ordinals, which allows data such as text, images and videos to be inscribed directly on-chain, people have now realized they can do the same thing on Ethereum and other Ethereum Virtual Machine (EVM)-based chains by

inscribing data on transaction call data. As such, inscriptions are being heavily used on other chains, but much of the activity is the same users spamming tiny mints repeatedly due to the lower cost of minting compared to smart contract interactions. In addition, such activity has caused Arbitrum, Avalanche, Cronos, Celestia, zkSync and The Open Network to have all experienced partial or full outages recently. While some suggest EVM inscriptions are the latest way for retail traders to access low-cap coins, others argue it's an over-hyped fad.

Bitcoin mining fees eclipse standard block rewards in market shift

Bitcoin mining fees are surpassing conventional miner rewards due to heavy inscription-related activity. In fact, fees for some blocks have exceeded 7.2 BTC, worth around \$300,000. This trend could influence miners' strategies and the dynamics of Bitcoin mining, and highlights demand for Bitcoin blockspace.

Belgium to Push European Blockchain Network During EU Council Presidency, Digital Minister Says

Belgium is set to take on the presidency of the EU Council in January, and Belgium's Digital Minister revealed that during its six-month presidency, it plans to gather political support for an EU-wide blockchain initiative. Eight member states are already on board for the project, where the European-wide blockchain network will reportedly start by storing drivers licenses and property titles.

Solana Price Rallies to \$100 Unseating BNB Coin for Fourth Spot

SOL surpassed XRP this week and briefly overtook BNB for the fourth largest cryptocurrency by market cap. SOL's price neared \$100, and Solana has gained over 75% over the month. Much of the price action is due to rising activity on the chain, successful recent airdrops, and the strong performance of several memecoins.
