New Bitcoin ETFs See Record Daily Flows As Total BTC Holdings Rise to \$3 Billion

News

Through five days of trading, net flows into newly launched Bitcoin spot ETFs totaled \$1.1b. Under the hood, Grayscale has seen \$2.2b of net outflows, while the other nine ETFs saw inflows of \$3.3b. BlackRock (iShares) and Fidelity are off to an early lead, each having accumulated over \$1b of assets already.

Glitch in upgrade of Ethereum Goerli testnet won't delay Dencun rollout

Ethereum's Goerli testnet successfully forked to "Dencun," Ethereum's next upgrade featuring EIP-4844 and Proto-Danksharding. A bug in the Prysm client caused a delay in finalizing blocks, but was quickly resolved and most anticipate the preliminary testnet schedule to hold and for the mainnet upgrade to occur by the end of March.

Crypto Advocates See Coinbase's SEC Hearing as a 'Step Forward'

Oral arguments in Coinbase's motion to dismiss the SEC's lawsuit against it kicked off on Wednesday. The SEC sued Coinbase on June 6, 2023, alleging that the cryptocurrency exchange violated federal securities laws and that 13 tokens listed on Coinbase were securities. Coinbase has requested that New York District Judge Katherine Polk Failla dismiss the suit, questioning the

SEC's authority over crypto exchanges and noting that the regulator never suggested a requirement to register as a securities exchange when it approved Coinbase's registration statement in April 2021.

Ether price jumps 20% vs. Bitcoin as BlackRock boosts Ethereum ETF bets

Ether (ETH) has gained over 20% against Bitcoin (BTC), as traders turn their attention to the possibility of a US spot Ether ETF. While some analysts like Bloomberg's Eric Balchunas have pegged the odds of approval at 70%, others expect the applications to be denied. The SEC is expected to rule on spot Ether ETF applications on or before May 23.

TUSD stability questioned as value dips below one dollar

Stablecoin TrueUSD (TUSD) has dropped below its dollar peg following a massive sell-off as traders sold over \$300m worth of TUSD for USDT on Binance. TrueUSD attributed the depeg to Binance Launchpool activities and deployed a new daily attestation service from an accounting firm to try to recover its peg, though the stablecoin continues to be priced below \$0.99.
