Bankrupt FTX Plans to Repay Creditors in Full: Squashes Restart Ploy

Collapsed crypto exchange FTX expects to fully repay its creditors, but customer assets will be evaluated based on their value as of November 2022. In addition, FTX revealed that it does not plan to restart the cryptocurrency exchange, as no investor is willing to commit the necessary capital.

Ethereum's Dencun upgrade goes live on Sepolia testnet

Ethereum's latest major upgrade Dencun went live on the Sepolia test network on Tuesday, and was a success. Holesky, the final testnet, is scheduled for February 7 before Dencun goes live on mainnet, likely in March. The Dencun upgrade features EIP-4844 and proto-danksharding, which introduce a new blob-carrying transaction that will significantly lower the cost of posting data back to mainnet by L2s.
