SEC Targets Robinhood's Crypto Trading Arm with Potential Enforcement Action

CryptoCurrency Finance Magnates

The SEC issued a Wells Notice to Robinhood Crypto on May 4, indicating that the regulator is planning to bring an enforcement action against the company. Robinhood expressed disappointment with the SEC's decision, stated it attempted to collaborate with the SEC to gain regulatory clarity, and that it's confident that listed assets are not securities. The move reflects broader regulatory challenges in the crypto market, with Uniswap and Consensys also having received Wells Notices from the SEC recently.

Grayscale backs off from its Ethereum futures ETF application

Grayscale withdrew its 19b-4 filing for an Ethereum futures ETF, which would have been an important part of getting a spot Ethereum ETF approved in the same manner as the spot Bitcoin ETFs. While Grayscale stated it withdrew the filing to focus on converting its Grayscale Ethereum Trust (ETHE) to a spot ETF, experts were confused by the move and questioned whether Grayscale wanted to spend the time and money on a lawsuit that could lead to ETHE outflows should spot Ethereum ETFs ultimately be approved.

FTX plans full pay back of all creditors plus billions in compensation

Bankrupt crypto exchange FTX's newest proposal to pay victims back over

its 2022 collapse now promises to repay all creditor claims plus "billions in compensation for the time value of their investments". While some argue the repayment amounts are still not enough and the plans are still subject to court approval, it is a significant improvement over prior plans and will return \$14.5-16.3b in total to creditors.

Mastercard joins forces with US banking titans for tokenized settlement trials

Mastercard, along with major US banks like Citigroup and JPMorgan, is testing distributed ledger technology for banking settlements using tokenization. The Regulated Settlement Network (RSN) aims to streamline settlement procedures by converting assets into tokens and settling them on a single platform. The ongoing trials focus on simulating settlements in the US dollar, with the goal of increasing efficiency and reducing errors and fraud in cross-border transactions. Key participants also include Visa, Deloitte, and the USDF Consortium.
