Ethereum ETF issuers eagerly waiting on the SEC to provide details on potentially final filings: Sources

The prospective spot Ethereum ETF issuers sent in revised S-1 forms to the SEC on July 8th. While there will be at least one more round of comments and revisions, the SEC's requested changes were said to be extremely minimal, and as such, SEC approval of the S-1s and subsequent launch of the funds could come anytime now, including as soon as next week.

SEC Drops Investigation into Stablecoin Issuer Paxos

The Defiant

The SEC sent a termination notice to Paxos regarding its investigation into the BUSD stablecoin and revealed it will not recommend enforcement action against Paxos. The move comes just two weeks after a US federal judge ruled that BUSD does not comprise a security. Also this week, the SEC dropped its investigation into Hiro, the developer behind Bitcoin L2 Stacks.

Germany Almost Done Selling Bitcoin, Holding Less Than 5K Tokens After Latest Moves

The German state of Saxony continued to send Bitcoin to exchanges and OTC trading desks over the week. While some criticized Saxony for selling, such a practice is mandated per the state's confiscated asset protocol. In addition, German authorities have less than 5,000 Bitcoin left in their known wallets, indicating that selling pressure from this source is mostly over.

House fails to counter Biden veto and rescind SAB 121 in latest vote

The US House of Representatives failed to overturn President Biden's veto of a measure that would have rescinded the SEC's controversial crypto custody accounting policy SAB 121. However, the vote was expected to fail, and news came out that the SEC is reportedly granting exceptions to the policy for some banks and brokerages.

Bitcoin to be added to the official Republican 2024 platform after today's vote

The Republican Party's 2024 platform includes support for Bitcoin and crypto. Specifically, the Republicans both criticized the democrat-led crypto "crackdown" and promoted the rights to self-custody digital assets and transact out of the view of the government. The move reflects a shift towards embracing digital assets and blockchain technology, aiming to position the US as a leader in the emerging digital economy.
